

Why do we need a strategy?

- ✓ Maximise the impact of community benefit
- ✓ Leave a positive legacy locally
- ✓ Ensure the fund priorities are relevant to the geographical area of the project
- ✓ Distribute benefit in a planned, fair and sustainable way
- ✓ Form the basis of the project evaluation criteria

- Potential areas of impact and local priorities under each stream
- Proposed fund structure and mechanisms (for example 3 separate funds, participatory budgeting scheme, single grant round, and so on)
- Types of projects and initiatives for support
- Potential partnerships and collaborations
- Co-funding opportunities


What will the Forum member's role be?



Forum members play a key role in developing the Community Benefit Strategy:

- To ensure that the scheme is designed for the local community, by the local community
- To provide relevant input and key local knowledge
- To communicate with the wider community and encourage participation
- To encourage collaboration and actively integrate different perspectives from the community
- To agree the criteria and parameters of the fund in collaboration with EirGrid and SECAD

Anticipated Community Benefit Timeline








Community Stream 1-2-1 Feedback

- ✓ A lot of large-scale capital investment projects - mostly community centres, sports facilities
- ✓ Requirement for technical support (e.g. architects, engineers, professional expertise)
- ✓ Outdoor socialising spaces & walkways
- ✓ Signage and village enhancement initiatives
- ✓ Need for youth facilities and non-sporting activities, particularly for teenagers
- ✓ Playgrounds
- ✓ Festivals
- ✓ Improved accessibility
- ✓ Inclusion initiatives to integrate new families and new communities into towns and villages





Sustainable energy benefits 'People, Planet and Profit'

People

Communities can become more resilient and empowered
Energy projects can create and sustain local skills employment

Planet

Reduced GHG emissions
Protection of natural resources
Healthier towns and villages

Profit

Homes and buildings become more comfortable, and more efficient and cheaper to run.
More money stays in the local economy with lower energy costs and with locally produced energy.



Sustainable Energy



- The EirGrid Community Benefit Fund can support communities to identify and start an energy project.
- The Sustainable Energy Authority of Ireland (SEAI) provide advice, expertise and funding for community energy projects.
- The first step in community energy projects is to set up a **Sustainable Energy Community (SEC)**, and set out the goals and ambitions of your community.
- With the support of an SEAI mentor your SEC can apply for Energy Masterplan funding
- The Energy Masterplan is carried out by an energy consultant and will involve input and consultation with your community
- The Energy Masterplan will establish an energy baseline of your community, identify opportunities for energy projects, and prioritise actions and projects.






- ✓ Will require Tidy Towns input
- ✓ Biodiversity trails and signage
- ✓ Pollinators
- ✓ Parks & Gardens
- ✓ Lakes & Waterways
- ✓ Woodlands
- ✓ Links with Greenways and Cycle routes
- ✓ Rewilding projects
- ✓ Improving infrastructure at biodiversity sites (e.g. car parks, signage, accessibility)
- ✓ Digitalisation – apps, QR codes, VR, videography
- ✓ Conservation of habitats & management of invasive species
- ✓ Training and education




The biodiversity stream aims to

- develop projects that will benefit the locality and leave a lasting positive biodiversity legacy

- Wildlife Education Programmes: 'Talks and Walks'







Youghal Tidy Towns BAP

Action	The Slob Bank and Youghal Mudlands	Year
SB-1	Explore the possibility of erecting interpretive signage highlighting the importance of habitats and species surrounding the Slob Bank on the Slob Bank.	2
SB-3	Work with the council and other stakeholders to develop a regime to manage grasslands bordering the Breton Road using pollinator friendly techniques.	1-2
SB-4	With relevant stakeholders (e.g. owners, NPWS), identify a small area of grassland on slopes at the south end of the Slob Bank Walk, outside of the SAC, to manage using a once a year cut-and-lift approach and monitor to see if this increases plant diversity. This would have to take account of life cycles of resident and visiting bird species.	1


