The Reason for the Recommended Modification:

On review of section PPM1, it came to our attention that the list of sections in clause PPM1.3.2 had a typo error. Grid Code clause PPM1.3.2 sets out a list of additional sections of the Grid Code that a Controllable PPM and Energy Storage Power Station Demand unit must comply with in addition to the requirements set out in PPM1.

A review of the previous versions of the Grid Code revealed that a re-numbering error occurred when transitioning from Grid Code version 5 to Grid Code version 6. At the time Grid Code version 6 was a re-formatted version of the Grid Code.

We propose fixing the typo error in this modification recommendation paper.

On the 2 July 2020 this modification proposal was presented to the GCRP members.
