The aim of this Qualification Information Pack is to provide information to prospective RESS 3 Applicants to enable them to participate in the RESS 3 qualification process. Prospective RESS 3 Applicants should ensure that only the documents included (or linked to) here are used in any RESS 3 Application for Qualification.

Submission of Applications for Qualification will be facilitated through the RESS Auction Platform. A guide on how to register and navigate through the system will be published in advance of the Qualification Application Opening Date in the RESS 3 Auction Timetable.

In this Qualification Information Pack, prospective RESS 3 Applicants will find the necessary forms (or links thereto) that will need to be provided in the Application for Qualification.

This pack includes the RESS 3 Auction Timetable, which outlines key dates that will take place throughout the year for the RESS 3 Auction.

## 4 RESS 3 Auction Qualification

The RESS 3 Qualification Process (R3QP) contained in this pack includes a detailed step-by-step guide to enable RESS 3 Applicants to clearly understand exactly what is required of them to participate in qualification for the RESS 3 Auction from the Qualification Application Opening Date to Final Qualification Decisions Date. Timings of key activities are also illustrated in the process in line with the dates identified in the RESS 3 Auction Timetable. The RESS 3 Qualification Process consists of the steps associated with qualification submission, qualification assessment and qualification results.

## 5 RESS 3 Auction Timetable

The latest RESS 3 Auction Timetable (R3AT) is included in this Qualification Information Pack.

## 6 RESS 3 Bid Bond Submission and Return Forms

A Bid Bond means a cash security lodged by an Applicant in respect of an Application for Qualification in accordance with the RESS 3 Terms and Conditions.

Each Applicant must provide a Bid Bond to the TSO by the Bid Bond Posting Date in accordance with Section 9.3 of the RESS 3 Terms and Conditions. The Bid Bond value in RESS 3 is €6 per MWh, where the MWh value is the Deemed Energy Quantity for one year for the RESS 3 Project calculated pursuant to Section 6.6.4 and multiplied by 1,000 to convert from GWh to MWh (the “**Bid Bond Required Amount**”).

In accordance with section 9.3.1 (c) of the RESS 3 Terms and Conditions, where an Applicant does not post the required level of Bid Bond by the Bid Bond Posting Date the **TSO shall reject the relevant Application for Qualification for the ORESS 1 Auction.**

In this section there are two forms relating to Bid Bonds which ***must*** be fully completed and submitted as part of the Application for Qualification by all Applicants. The two forms to be uploaded to the RESS Auction Platform are described in more detail below.

### 6.1 RESS 3 Bid Bond Submission Form

When an Applicant is submitting an Application for Qualification in respect of the RESS 3 Auction, they must post a Bid Bond in a single payment to be cleared in the TSO RESS Account no later than the Bid Bond Posting Date. As part of this process, all sections of this form (R3BB1) must be completed. This form must be signed by a director.

It is vital that this form is completed correctly; in particular, **it is important that the RESS 3 Application Reference (as assigned in Application for Qualification: RESS3-4 Digits) is included within the payment reference when a payment is being made** in order for the TSO to safely and securely link a submitted Bid Bond to a RESS 3 Project.

## 6.2 RESS 3 Bid Bond Return Form

When an Applicant is submitting an Application for Qualification in respect of the RESS 3 Auction, they must also submit a RESS 3 Bid Bond Applicant Return Form (R3BB2). This form will be used by the TSO where a Bid Bond is to be returned to an Applicant. This form must be signed by a director.

## 6.3 Bid Bond calculations

See below worked example of Bid Bond calculations for each technology type. In these examples we have included a 10 MW project in each case.

Any Capacity Factor utilised in the calculation of a Bid Bond other than the Renewable Capacity Factors (RCF) contained in Table 2 of the RESS 3 Terms and Conditions will result in the incorrect amount being calculated with the consequences as outline above and in the Terms and Conditions.

The only calculation which differs from the above is “RESS Hybrid Wind and Solar”, which is a little more complex as it must be adjusted for the MW amount of each technology.

*Bid Bond Amount x MW x Hours per annum x Adjusted Renewable Capacity Factor*

The Adjusted Renewable Capacity Factor is equal to the (Amount of Wind \* Capacity Factor) + (Amount of Solar \* Capacity Factor) all divided by the total MW amount.

In this instance the total MW Amount is 10MW, split as 5MW Wind and 5 MW Solar.

$RCF = ((0.35*5)+(0.11*5))/10 = 0.23$ . Note, this value will change depending on the project split so will have to be calculated by the applicant.

## 7 RESS 3 Application for Review Form

In accordance with the RESS 3 Terms and Conditions, an Applicant who considers that the TSO has not applied the Terms and Conditions correctly in the Provisional Qualification Decision, can submit an Application for Review (R3AR) to the TSO. **The Application for Review must be received by the TSO no later than two working days after receipt by the Applicant of the Provisional Qualification Decision.** This form can be signed by an authorised user.

## 8 RESS 3 Notice of Application Withdrawal

An Applicant, who has submitted an Application for Qualification in respect of the RESS 3 Auction and who no longer wishes to participate in the RESS 3 Auction, can issue a Notice of Application Withdrawal (R3NW) to the TSO. **The Notice of Application Withdrawal must be received by the TSO no later than the Final Application Withdrawal Date in the RESS 3 Auction Timetable.** This notice can be signed by an authorised user. The Notice of Application Withdrawal is irrevocable, and the Application for Qualification will not be considered further for the RESS 3 Auction.

## 9 RESS 3 Notice of Dissatisfaction

An Applicant who, following a TSO decision with respect to an Application for Review, considers that the TSO has not applied the Terms and Conditions correctly in their decision on the Application for Qualification or the Application for Review, can submit a Notice of Dissatisfaction (R3ND) to the Minister. The Applicant should detail the relevant provisions of the RESS 3 Terms and Conditions that they consider have not been applied correctly by the TSO.

**The Notice of Dissatisfaction must be received by the Minister no later than two working days after receipt of the TSO decision.** The notice should be accompanied by the TSO decision in respect of the Application for Review. This form can be signed by an authorised user.

## 10 RESS 3 Landowner Consent Confirmation

The RESS 3 Applicant must possess and demonstrate control of the Site of the RESS 3 Project and the right to access this Site for the purposes of developing and operating the RESS 3 Project.

Compliance with this requirement must be evidenced by the Applicant submitting a RESS 3 Landowner Consent Confirmation Form (R3LCC) in line with the RESS 3 Terms and Conditions. **This form must be signed by a director and witnessed and signed by a solicitor.**



## 11 RESS 3 Director Declarations

There are seven director declarations to be included in the Application for Qualification as per the RESS 3 Terms and Conditions. **All seven director declarations must be made by way of an individual sworn affidavit and signed by a practising solicitor.**

Templates for each of seven director declarations are linked in this Qualification Information Pack above in section 2. In accordance with Section 9.2.2 of the RESS 3 Terms and Conditions, all declarations made in connection with the RESS 3 Auction must be in the form provided in this pack. Any declarations submitted which are edited, amended or otherwise altered in any way which is not permitted by the form of declaration will be deemed invalid.

## 12 RESS Auction Platform

Applications for Qualification will be submitted via the RESS Auction Platform. To access the RESS Auction Platform, prospective RESS 3 Applicants will be asked to register prior to the Qualification Application Date.

Communication will be issued with a link to the RESS Auction Platform and a detailed guide on registration as well as how to navigate through the Platform.

As part of the registration process, the prospective RESS 3 Applicant must submit a RESS Authorised User Form (RAU1) in PDF format outlining who will be authorised to submit an Application for Qualification. This form must be signed by a Director. Proof of all Directors of the company must also be submitted with this form.

- If a RESS Authorised User is not an existing user of the RESS Auction Platform, the RAU1 form must be submitted via the RESS Auction Platform.
- If a RESS Authorised User is an existing user of the RESS Auction Platform, the RAU1 form must be issued to [RESS@eirgrid.com](mailto:RESS@eirgrid.com).

Prospective RESS 3 Applicants must be a Grid Contracted Project as that term is defined in the RESS 3 Terms and Conditions. All Prospective RESS 3 Applicants must provide their Grid Reference Number in their Application for Qualification.

A unique email address and mobile number is required to access the RESS Auction platform. On each visit to the platform, users will be issued with a code to their mobile phone which must be entered to complete the logon. The same email address cannot be used for more than one user account. This is to ensure a high level of security on the platform.

## 13 Financial Questionnaire

Following Final Qualification Decisions, Qualified Applicants must submit a Financial Questionnaire to DECC. The Financial Questionnaire must be submitted no earlier than the Financial Questionnaire Submission Opening Date and no later than the Financial Questionnaire Submission Closing Date specified in the RESS 3 Auction Timetable.

As stated in Section 6.6.1 of the RESS 3 Terms and Conditions, Qualified Applicants must complete and submit the Financial Questionnaire found in Annex B of the RESS 3 Terms and Conditions to the Minister (to be submitted for the attention of RESS Team, Renewable Electricity Division at the Address and/or Email Address specified at Clause 11 of the Implementation Agreement). The information submitted in this Financial Questionnaire must be true and accurate at the time of submission.

Please note the Financial Questionnaire must not be submitted to EirGrid.
